Sealed Bids will be received at the office of THE TOWN OF COEYMANS TOWN CLERK, 18 RUSSELL AVENUE, RAVENA, NY 12143, until 2 pm local time on April 25, 2017, and then at said office publicly opened and read aloud for:

Wastewater Treatment Plant Upgrades including a mechanical fine screen, two grit screws, channel modifications, aeration system, and a sludge dewatering building. The Work will have multiple primes.

The Project shall be completed within 250 calendar days after the date when the contract time commences to run.

A pre-bid meeting at the WWTP is scheduled for March 28, 2017 at 10 am.

Bids will be received for a multiple prime Contracts for General Construction and Electrical. Bids will be received on a lump sum basis.

Bids should not include sales and compensating use taxes on materials incorporated into the work.

Bids actually received by mail or by hand after the appointed time on the date specified shall be rejected, notwithstanding that such Bid may have been placed in a mail box or other mail receptacle regularly maintained by the United States Postal Service before such time, and ordinarily in sufficient time to have been delivered on time.

Bid security in the amount of 5% of the Bid must accompany each Bid in accordance with the Instructions to Bidders.

The successful Bidder will be required to furnish a performance bond and a payment bond, each in an amount equal to 100% of the contract price.
