**AUTHORIZATION FOR PUBLIC HEARING ON BUDGET**

Supervisor Youmans stated that they need to put a Notice of Public Hearing in the News Herald on Thursday, November 4<sup>th</sup> at Town Hall at 7:00pm.

Councilman Boehm interjected that the purpose of the Public Hearing would be to receive comments on the 2011 budget.

Town Clerk Millious stated it has to go in next week’s paper.

Supervisor Youmans stated that was correct and added that no matter what they have to have the Public Hearing even if they open it and then adjourn. He continued by saying that he thought this might have to happen but after what they have accomplished and will accomplish on Tuesday, he thinks they will be ready.

Town Clerk Millious stated that when she does the Notice, she has to show the Elected Officials salaries.

Supervisor Youmans stated that it is as follows:

Supervisor	(1)	\$30,000.00
Councilman	(4)	\$12,000.00 each
Justice	(2)	\$17,500.00 each
Highway Supt.	(1)	\$50,000.00
Town Clerk	(1)	\$40,500.00

Councilman Boehm inquired about the Deputy Supervisor position.

Town Clerk Millious stated that Deputy Supervisor is not an Elected Official but rather an appointed position and does not have to show. She continued by saying that the Notice also says that the Preliminary Budget is available and added that it is not in hand.

Supervisor Youmans stated that she should leave that sentence out and added that by the time that Thursday rolls around, which is the official day for publication, it may be ready.

Town Clerk Millious stated that it will be next week.

Supervisor Youmans reiterated that she should leave the sentence out and if people come looking for it, she can say that they are not finished with it yet because of the circumstances.

Town Clerk Millious stated that she can keep a list of anyone wanting a copy and in turn as soon as she has it, she can let them know.

Supervisor Youmans stated that it was a good idea and added that the only change to the Elected Officials salaries is for Supervisor
