PUBLIC COMMENT

Supervisor Crandall invited the public to comment at this time then moved on to the next item on the agenda when no one wished to comment.

APPROVAL OF MINUTES

Supervisor Crandall stated that there is one set of minutes for Town Board approval, a Town Board Meeting on November 30th and then asked for a motion to approve them.

MOTION

On motion of Councilman Dolan, seconded by Councilman Burns, the minutes were approved as presented and read.

PRESENTATIONS

Rick Touchette, Albany County Legislator. Mr. Touchette stated he had a couple of things he would like to mention tonight. The first is that last week the Legislature approved a structurally sound six hundred seventy eight million dollar budget. The budget has no use of reserves, no tax increase or layoffs and a two percent raise for most County employees. He is most impressed with how Albany County continues to take care of seniors, youth and families with this budget. The entire budget is available online at the Albany County website where you can download a pdf copy of the budget. If anyone has any questions regarding the budget, he will be happy to try and answer them. The second thing is that Albany County has approximately fifty committees, boards and commissions that are mostly staffed by volunteers. They range from the Ethics Commission, Airport Authority, Land Bank to Soil & Water Conservation. If anyone has any interest in getting involved in County government let him know and he would be happy to help them. The last thing he would like to mention is that next Monday the Legislature will pass a resolution to authorize the distribution of mortgage tax for the period of April 1st to September 30th. The Town of Coeymans' distribution is \$66,917.63 and the Village of Ravena's distribution is \$12,799.61.

Mr. Touchette concluded by thanking Town Clerk Millious for her years of service to the Town of Coeymans and wished her the best in her retirement.

Councilman Dolan asked if there is a list of the committees, boards and commissions.

Mr. Touchette responded there is not a list in any one place, but he would be happy to help anyone looking for more information.

Councilman Dolan asked what he attributes Albany County's ability to have a zero tax increase, a two percent raise and no cuts to current positions to.

Mr. Touchette responded that part of the possibility is due to the increase in the tax levy and the tax base. There is very little fat in the budget, as well as a carefully crafted partnership between the executive branch and the legislature that also helped to make this budget possible. Mr. Touchette stated it is a very open and transparent process.

Craig Hightower, NRG Community Solar Energy. Mr. Hightower stated he would be filling in for Steve Smith, who is home sick. They would like to officially introduce the use of community solar energy to the Town and will be working in the area. When most people hear solar energy, they think it means having solar panels on their roof. That has been the case for many years as there were no other options available. Community solar allows people to go solar, reducing their carbon footprint and having the benefits of solar energy without putting solar

panels on their roofs. This is in the form of a community solar garden or farm, essentially it is a one to three acre parcel of land with solar panels. This allows rate payers to Central Hudson to get the credits that come with the solar production from the farm. It comes in the form of a net metered credit, which is the same concept as having the panels on your roof. The average subscriber to the farm is off setting the amount of carbon in the environment equal to a car driving 14,000 miles a year or planting 153 trees. NRG has over 14,000 current subscribers in Minnesota, Massachusetts, Colorado and now New York. This is a new concept, they will be in the area and wanted to provide some insights in to some of the benefits available, the chance to go green, reduce the carbon footprint on the environment and save some money as well.

Councilman Youmans asked if they had plans to build a garden here.

Mr. Hightower responded yes they do, the specifics locations are not available at this time as the locations could change, but permits have been obtained to build approximately fifteen gardens on the Central Hudson grid that covers from Albany to Poughkeepsie on both sides of the river.

Barbara Heinzen asked about the placement of the panels on land used for agricultural purposes and the impact on being able to plant on the land. She asked if their company had looked into raising the panels off the ground so crops could be planted on the same piece of land, allowing for a higher return through both solar energy and agricultural products from the land.

Mr. Hightower responded that they currently do not build on land being utilized for agricultural purposes and they do place the solar panels above the ground.

Councilman Langdon asked about the benefits, is this something you sign up for.

Mr. Hightower responded that there are no upfront costs; it is a 20 year subscription with flexible terms. There are options and solutions available if you move away. People can schedule an appointment with them and they will go over all the terms, details and break down your current bill to show the savings potential. There is information also available on their website.

Michael McGuire, assessor for the Town of Sand Lake and assistant assessor for the Town of Fort Ann. Mr. McGuire stated there were recent changes to NYS Legislation for the Cold War Veterans exemption. In September of this year the Governor signed a bill to remove the Sunset clause governing the Cold War Veterans exemption. The Town of Coeymans currently does follow the exemption. He would like to propose the Town adopts a law to remove the sunset clause from the Town's legislation for government exemptions. The way it was established in 2009, the law was written that the exemption would expire in 10 years, so the individuals currently receiving this exemption would lose it in 2019. If the Town adopts this law the individuals who receive this exemption would be able to continue to receive it. Mr. McGuire stated it is a fairly simple local law and he has printed out a copy for the Town Board. This exemption is a little different from other veteran's exemptions, it focuses on veterans who served during the Cold War period. The Cold War period is defined as the period after WWII, September 1945 through December 1991, through the Persian Gulf conflict. It does exclude the periods of conflict that include Korea and Vietnam, these periods are covered by an alternative exemption. Both exemptions are pretty much the same, they just cover different time periods.

Councilman Dolan asked, so veterans would be eligible for one or the other.

Mr. McGuire responded yes, they could receive on or the other; but not both.

Supervisor Crandall stated the exemption is something that is very well deserved and needed by our veterans.

The Town Board collectively thanked Mr. McGuire.

Councilman Youmans read proposed Local Law #1 for 2017 aloud.

PROPOSED LOCAL LAW #1 OF 2017

A LOCAL LAW OF THE TOWN OF COEYMANS, COUNTY OF ALBANY, NEW YORK, AMENDING LOCAL LAW 1 OF 2009 TO ELIMINATE THE TEN YEAR LIMITATION ON TAX EXEMPTIONS FOR COLD WAR ERA VETERANS

Be it enacted by the Town Board of the Town of Coeymans as follows:

Section 1. Purpose: Local Law 1 for 2009 provided for certain tax exemptions for Cold War Veterans with a ten year limitation on the receipt of the exemption. The purpose of this Local Law is to adopt a provision removing the ten year limitation on the receipt of the exemption as permitted by Chapter 290 of the 2017 Laws of the State of New York which authorized a town to remove the ten year limitation on receipt of the exemption by qualified owners of qualifying real property as long as they remain qualifying owners.

Section 2. Section 4 of Local Law 1 for 2009 is amended to read as follows:

A. If the Cold War Veteran receives the exemption under any other section of Real Property Tax Law that provides for veteran exemptions, the Cold War Veteran shall not be eligible to receive the exemption under this Local Law.

B. Application for exemption shall be made by the owner, or all of the owners of the property on a form prescribed by the State Board. The owner or owners shall file the completed form in the Assessor's Office on or before the first appropriate taxable status date. Applicant shall file on or before the appropriate taxable status date. Any applicant convicted of willfully making any false statements in the application for such exemption shall be subject to the penalties prescribed in the New York State Penal Code.

Section 3. Effective Date: This Local Law shall take effect immediately and shall apply to Assessment Rolls prepared on the basis of taxable status occurring on or after such date.

MOTION

Councilman Langdon sked if Mr. McGuire knew what the value of the exemption would be to veterans.

Mr. McGuire responded that he did not off the top of his head, but it is usually a percentage of the taxable value of the property, with a cap.

Mr. McGuire stated that the RCS School District has not adopted this yet and it is something that can be extended to school districts as well. He suggested that the Town might want to draft a letter to the school district regarding this matter.

RES. # 126-17 ESTABLISH 2018 SEWER RATES

WHEREAS, the Town of Coeymans is required to establish Sewer Rates for 2018; and

WHEREAS, a Public Hearing was duly advertised in the official newspaper of the Town of Coeymans and held on December 14, 2017 at 6:30 PM at Town Hall; and

WHEREAS, all parties in attendance were granted an opportunity to speak on behalf and/or opposition to the proposed 2018 Sewer Rates; and

WHEREAS, the Town of Coeymans determines the number of units to calculate the billing for operation/maintenance/capital projects; and

WHEREAS, each use is hereby charged the following:

Per unit, per year – Five hundred nine dollars and thirty cents (\$509.30)

January–June Payment – Two hundred fifty-four dollars and sixty-five cents (\$254.65)

July-December Payment – Two hundred fifty-four dollars and sixty-five cents (\$254.65)

Commercial - one (1) unit per use

Apartments – one (1) unit per apartment

Out of district users – per unit, per year

Vacant parcels – flat rate of One hundred dollars (\$100.00) per year

Village of Ravena – Thirty-five thousand, one hundred thirty-eight dollars and seventy-six cents (\$35,138.76) per month

WHEREAS, the Town Board of the Town of Coeymans has established a late payment of ten percent (10%) to be imposed on all balances thirty (30) days from the due date of the billing.

NOW THEREFORE, BE IT RESOLVED that the Town Board of the Town of Coeymans does hereby authorize the Town Clerk to collect sewer rents for 2018, pursuant to the above established rates.

Councilman Dolan stated that the rate last year was \$506.83 so this is an increase of \$2.47 which is less than a half one percent.

WHEREAS, the Town is permitted by virtue of section 122-b of the General Municipal Law of the State of New York to provide emergency ambulance service for the purpose of treating and transporting sick and injured persons found within its boundaries to an acute care hospital; and

WHEREAS, the Town is desirous of entering into an agreement providing such ambulance service to the Town of Coeymans pursuant to said provisions of law; and

WHEREAS, the Ravena Rescue Squad has trained and experienced personnel and is certified by the NYS Department of Health as an ambulance service; and

WHEREAS, the Ravena Rescue Squad is desirous of furnishing emergency medical services to said Town under the terms and conditions set forth in the Emergency Medical Services Agreement 2018;

NOW THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Coeymans hereby authorizes Supervisor Philip A. Crandall to execute said Emergency Medical Services Agreement 2018 this date December 14, 2017.

RES. # 129-17 AUTHORIZE SUPERVISOR TO SIGN SRO AGREEMENT

WHEREAS, Article 5G of the General Municipal Law specifically authorizes and encourages municipal corporations to enter into agreements with each other in order to provide cooperatively, jointly or by contract any facility, service, activity or undertaking which each participating municipal corporation has the power to provide separately; and

WHEREAS, the respective governing boards of the Town of Coeymans and the Ravena Coeymans Selkirk Central School District have determined that it is in their mutual best interests to enter into an

agreement for the placement of one or more School Resource Officers (SRO) in the School Districts High/Middle School;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Coeymans does hereby authorize Supervisor Philip A. Crandall to execute an Intermunicipal Agreement with the Ravena Coeymans Selkirk Central School District for SRO (Agreement Attached).

RES. # 130-17 APPOINT POLICE OFFICERS TO COMPETITIVE STATUS

WHEREAS, the Town of Coeymans’ Chief of Police has a need to increase hours worked by two part time Police Officers in the Police Department in order to meet staffing needs; and

WHEREAS, Officer Rinaldi and Officer Schwebke have recently completed all steps necessary to be appointed from the Competitive Police Officer Exam from Albany County Civil Service;

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Coeymans does hereby appoint Officers Brian Rinaldi and Kevin Schwebke to the position of Competitive, Part-Time Police Officer effective December 18, 2017, contingent upon approval by Albany County Civil Service. These Officers will be compensated at the rate designated in the current Collective Bargaining Agreement.

Supervisor Crandall asked Chief of Police McKenna if he wanted to comment on this.

Chief of Police McKenna thanked the Town Board for approving this request. Officer Schwebke has been with the department for four years and Officer Rinaldi eight years and he appreciates the opportunity for them to work more than the one thousand forty hours they are restricted to under civil service law. Officer Schwebke is currently the SRO, so this will allow him to work a full slate in his SRO position.
