- a. Carver Laraway submitted request to make extended docks permanent. If you review the aerial orthoimage maps, you notice that the area is significantly narrowed for ships and yachts.
  - i. This could cause additional hazard for recreational vehicles.
  - ii. The scale of expansion may be out of scale with the local community.
- b. Another plan was to fill 23 acres of land from 65 feet to 144 foot flat elevation near the Coeymans creek. This might be supplemented with construction fill which could be considered importing industrial waste from in state.
