Searles voiced his concern that the \$5,000 had not been put back in his budget for DB1640.4 as had been discussed at the Budget Workshop.

Supervisor Crandall and Councilman Dolan stated that it had been overlooked and would be put into the Adopted Budget.

Public Comment

Mr. Aaron Flach, Acting Chair of the RCS Business Association, stood and formally asked the Town Board if they would put the approximately \$15,000 in the Budget that he had mentioned before.

Supervisor Crandall thanked him and asked if there were any other comments from the audience.

Councilman Burns asked the Town Board to consider giving Frank Arnold a raise of \$1 an hour rather than the \$.60 an hour raise that had been put in the budget due to Mr. Arnold's concern that by the end of this year his men would be making more than him. Councilman Dolan stated that Mr. Arnold had asked for \$1.60 an hour raise and asked Councilman Burns if he was against that. Councilman Burns stated that he was but would be for \$1 an hour.
