WHEREAS, a prior Town Board appealed from the Decision and Order (the "Appeal"); filing a Notice of Appeal on December 1, 2023; and perfecting the Appeal on December 29, 2023; and

WHEREAS, the prior Town Board caused the Appeal to be taken on behalf of all of the named Respondent-Defendants; and

WHEREAS, the Appeal of the Decision and Order as it relates to the Town Supervisor and Town Clerk has been rendered moot in that the records sought have been produced; and

WHEREAS, the current Town Board now seeks to withdraw the Appeal, in so much as it is an Appeal on behalf of the Town of Coeymans and the Town Board of the Town of Coeymans.

NOW, THEREFORE, BE IT RESOLVED as follows:
